### **RESPONSIBILITIES:**

#### **First party:**

1) The college may make arrangements for organization of executive body meetings, General body meetings by Vizag NETBALL Association, Visakhapatnam for faculty & students at a time both the parties agree to without any financial commitment.



2) The college may make arrangements for organization of Exhibition matches, inter school tournaments, intercollegiate tournaments, friendly matches by Vizag NETBALL association, Visakhapatnam as part of their curriculum.

3) The college may make arrangements for the coaching camps to undergraduate and or post graduate students by NIS coaches of Vizag NETBALL Association, Visakhapatnam without any financial commitment.

**Second party:**

1) Vizag NETBALL Association, Visakhapatnam may arrange expert coaches to train the players in coaching camps in the premises of college without any financial commitment by both parties.

2) Vizag NETBALL Association, Visakhapatnam may conduct inter school intercollegiate sections, inter school tournaments, inter collegiate tournaments and exhibitions matches for the students as mutually agreed by both parties.

3) Vizag NETBALL Association, Visakhapatnam may organize executive body meetings, General body meetings of the first party as agreed mutually by both parties.

**CONFIDENTIALITY**

The College and Vizag NETBALL Association Visakhapatnam agree not to disclose or discuss details of this MOU to others at any point of time.

**VALIDITY**

The MOU shall be valid initially for a period of 5 years and extendable by mutual consent.

**SETTLEMENT OF DISPUTES:**

The parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Agreement or the interpretation thereof . If any disputes difference question or disagreement arises between the parties hereto or their respective representative or assignees in connection with construction meaning operation effect interpretation of the Agreement or breach thereof which parties are unable to settle mutually within 30 days from the commencement of settlements proceedings and if not settled then the same shall be referred to the court of Andhra Pradesh Jurisdiction.

## TERMINATION

The MOU may be terminated on expiry of the stipulated period or by giving a notice of one month or the conclusion of ongoing programs whichever is later from either side. This memorandum which is 03 pages is signed on 09-01-2023 and exchanged on 09-01-2023


