In the G.O. first read above, orders have been issued for regularisation of Part-time ecturers/Junior Lecturers working in Private Aided Degree/Junior Colleges and Junior Colleges with Vocational Courses in the State who fulfill certain conditions/norms as stipulated therein. Therefore, as the Commissioner of Collegiate Education has not considered the cases of Physical Directors/Librarians in Private Aided Junior Colleges, certain Physical Directors/Librarians (part-time) have approached the A.P.
